General Contractor Subcontractor Associate Industry Design Professional Supplier

Associate: Provide professional services, who are not involved in providing "construction type labor" on construction projects or project maintenance.

Industry Design: Architects and Engineers

Supplier: Directly involved in supplying materials/equipment to projects but does not provide on-site construction type labor.

Contractor/Subcontractor: Companies "directly involved on-site by providing labor as a contractor or subcontractor to construction projects" or "providing construction type labor" on project maintenance.

Startup: Contractor companies in business fewer than 3 years. Valid for up to 2 years at which point dues become based on volume.
